## ALTERNATIVE OPTIONS:

- Employees are strongly encouraged to attend the mass Biometric Screening Events. However, if you prefer to work with a different medical provider instead of attending an Event, employees may complete fasting blood work, blood pressure, and height and weight screenings from a different Medical Provider. Please follow instructions for submitting a Physician's Form, by the established deadline. Current Employees hired by 1/15/2018: Deadline is March 1st, 2018.
- In the event that an employee absolutely cannot attend one of the scheduled mass screening events and wants to receive the Biometric Screening from the Wellness Clinic, the employee may complete the Exception Request Form.

\* For employees who do not meet 2 of the 5 biometric values required for the Wellness Rate, you still have an opportunity to qualify for the Wellness Rate. For more information, see the Healthcare Provider Reasonable Alternative Form.

Spouses are NOT required to complete a biometric screening in 2018, however, they are invited and encouraged to sign-up to get screened at one of our free events to stay up-to-date on valuable health information.
