I agree to be courteous, respectful and to assist all voters fairly and equally. I agree to attend Election Judge Training, so I am prepared to fulfill my responsibility to conduct the election according to federal, state, and local election laws and policies. I understand that I am responsible for the security of election equipment and supplies, and I will handle and monitor all such equipment and supplies exactly as instructed. I agree NOT to bring newspapers, magazines or other public information materials that contain political ads or articles into the voting location. I agree NOT to use my cell phone for personal calls, text messages, or web browsing while performing my duties. I agree NOT to use the election computers for any personal use. I agree to report immediately to the Supervisor any malfunction or possible tampering of voting equipment, unusual or suspicious behavior occurring in the voting location, or any event or occurrence that may threaten the accurate gathering or sanctity of the vote.
