Dear Larimer County Business,

Thank you for your interest in the **B**usiness **H**azardous waste **P**rogram & **E**ducation (**BHAPE**). BHAPE offers qualified businesses an affordable safe option for recycling or disposal of hazardous wastes.

To use the program your business must:

- Operate and generate hazardous waste within Larimer County.
- Generate wastes approved through BHAPE.
- Package waste in containers 5 gallons or smaller, typically. Containers larger than 5 gallons must be preapproved.
- Fall under the classification of Very Small Quantity Generator (VSQG).

This packet of information contains a resource list, practical waste management tips, and a cost sheet that outlines disposal fees for the BHAPE program. The resource list is not an exhaustive list of vendors. Other vendors may be found by searching the internet. There are also numbers available if you should need to contact a government agency with questions or concerns and area laboratories that may be able to assist you with any testing or sampling needs. If your business does not qualify as a VSQG and you have questions about managing your waste properly, you may contact our office or the Colorado Department of Public Health and Environment (CDPHE) (303) 692-3320.

Before bringing your waste to the facility, you will need to contact a Larimer County Hazardous Waste Technician to assist you in becoming a BHAPE participant. Initial consultation with a technician is necessary, and your appointment to deliver waste may be made at that time if you meet the requirements of the program. A technician can be reached by calling **(970) 498-5773**.

Safety is a priority at the Larimer County Household Hazardous Waste Facility. You are encouraged to read the Practical Waste Management Transportation Tips, enclosed. Larimer County reserves the right to refuse waste that is not properly segregated, packaged, labeled, or represented by your company.


The Collection Facility is located at the Larimer County Landfill: 5887 S. Taft Hill Road Fort Collins, CO 80526. Wednesdays are reserved for BHAPE business appointments. If a business must dispose of waste during residential hours, an Unscheduled Appointment Fee of \$50 will be added to the standard pricing. Payment is accepted in the form of cash, credit cards, (American Express is not accepted) or checks made payable to Larimer County Solid Waste at the time you drop off your waste.

PRACTICAL WASTE MANAGEMENT TRANSPORTATION TIPS

- 1. Properly package all waste prior to shipment in Department of Transportation approved containers 5 gallons or smaller. Containers larger than 5 gallons must be preapproved.
- 2. Original containers in good condition may be used for transportation.
- 3. Please make sure that each container is clearly marked and legible or labeled with the contents of each container.
- 4. Unknown wastes are not accepted into the BHAPE program. A generator is responsible for properly identifying all waste.
- 5. Separate incompatible materials such as acids and bases.
- 6. Secure the load to prevent shifting and spillage.
- 7. You are responsible for any spillage, and you are responsible for cleanup or damages that may occur during transport of your waste.

BHAPE PaintCare Information:

Larimer County Solid Waste has a contract with PaintCare on the proper processing and recycling of unwanted paint. PaintCare is a non-profit product stewardship organization that works to make paint recycling of unwanted paint more convenient for states that have paint stewardship laws. With this partnership, Larimer County Solid Waste HHW now has an administrative processing paint fee for businesses that need to dispose of paint and are qualified for the BHAPE program.

\$0.25 per gallon based on container size or the \$10 minimum fee, whichever is greater, is Larimer County's administrative processing fee on business paint and paint related products. Acceptable PaintCare products include latex paint, oil-based paint, and stains. See below for what products are and are not accepted within the PaintCare Program. Businesses must note that oil-based paint and stains are considered hazardous which means that having 18 to 20 gallons of this paint may be over the 220 pound per month limit to qualify for Very Small Quantity Generator (VSQG). Also note, products that are not accepted within the PaintCare program do not qualify for the PaintCare administrative processing fee. However, these products are accepted from qualifying businesses through the BHAPE program at our current standard pricing. See BHAPE Disposal Fees for appropriate pricing of other types of waste outside of the PaintCare Program.

- Asbestos Material (call (970) 498-5771 for disposal information).
- Explosives Shock sensitive materials such as dynamite, ammunition, picric acid, etc..
- Pathological wastes and medicines infectious waste, medical waste, pharmaceuticals, etc..
- Known PCB waste
- Radioactives includes smoke detectors.
- Temperature Controlled waste
