CURRENT SITUATION:

DESCRIPTION: The Larimer County Emergency Operations Center (EOC) has been activated for 57 days and continues to respond to the effects of the Novel Coronavirus 2019 (COVID-19) pandemic.

The CO Department of Public Health and Environment has issued a Public Health Order based upon the Governor's Office "Safer at Home" Order. Because each county has different requirements and guidelines in addition to the state orders, the Larimer County Department of Health and Environment (LCDHE) has provided detailed information for Larimer County organizations and community members which can be found on the larimer.org/coronavirus website by clicking on "Safer At Home Phase." A local public health order will be issued later this week once all the guidance from the Governor's Office and CDPHE has been finalized.

Larimer EOC continues to work on a Suppression Plan as part of the Safer at Home Order that will outline safe measures for re-opening businesses and services in the county. Additionally, the EOC has developed early warning triggers that will prompt stricter precautions if we see that the Safer-at-Home measures are leading to challenges in our community. We are working in conjunction with the Colorado School of Public Health on data analyses as we move forward with Safer at Home guidance and we are working with businesses to ensure the suppression plan is accurate, feasible, and meets community needs.



ACS at the Ranch: The Ranch Alternate Care Site (ACS) was turned over by the U.S. Army Corps of Engineers to the State of Colorado on Friday as substantially complete. The Larimer EOC continues to work with the State of Colorado on additional areas that need to be completed before the site can open. The recent Stay at Home Order reduced peak infections and flattened the curve allowing the hospital systems to manage hospital admits from the COVID-19 virus. Therefore, the opening date of this facility will likely be later in May or early June.

Evacuation & Sheltering: The Larimer EOC, in partnership with the American Red Cross and the Larimer Emergency Telephone Authority has developed plans and procedures for evacuation procedures in a COVID_19 environment. The county is entering severe weather season and wildfire season. Therefore, public messaging will go out tomorrow providing community members instructions for how to evacuate safely while also maintaining social distancing measures. We ask all agencies to push out the messaging to their distribution lists.

Testing: Larimer County held another public drive thru testing site in Loveland on Friday. 58 people were signed up for testing. This was the final day of testing operations at this site. Testing operations will be moved on Monday to the CSU location and testing will resume Tuesday, May 5th. Testing also continues to be available for first responders, healthcare workers, critical infrastructure personnel, and Tier 2 patients needing testing (on a case-by-case basis). An online registration form has been posted on Larimer County's website and is available to take patient registrations: www.larimer.org/testing. LCDHE has trained a number of staff to conduct specimen collections as well.

Recovery: The Larimer Recovery Group is being formed. A Recovery Manager has been hired. Larimer OEM and the Recovery Manager will meet with the BCC and our municipal partners next week to discuss the structure of the Recovery Group for long-term operations. Hospital Status: All hospitals in Larimer County have taken measures to increase bed capacity, ICU capacity and ventilator capacity. At this point, the systems are running well without the need for medical surge. We have seen a slight increase in hospital admissions directly related to COVID-19 in


the past five days but will need more data to determine if it is an ongoing trend. The next few weeks will be crucial in determining how well social distancing and Stay-at-Home measures have worked to date.


LARIMER COUNTY RISK AND EXPOSURE:

Responders: Three responders have requested assistance with quarantine due to exposure to patients with positive test results. All three are now cleared.


Civilians: Larimer currently has 386 positive test results, 19 fatalities which includes probable COVID-related deaths.





Current State of Colorado and Larimer County Public Health Orders

On March 10, 2020, the Governor of Colorado declared a state of Emergency related to the presence of COVID-19 in the State. The Colorado Department of Public Health and Environment has confirmed that COVID-19 continues to spread throughout the State of Colorado. On April 9, 2020 Gov. Polis signed an Executive Order extending the disaster emergency declaration for COVID-19 for an additional 30 days.

On April 26, 2020, Governor Polis issued a state-wide "Safer at Home" order which allows for phased re-opening of Colorado communities. This Executive Order implements a number of measures that will allow many Coloradans to return to work while we maintain a sustainable level of social distancing. In particular, this Executive Order continues Social Distancing Requirements for all Coloradans and stay at home requirements for Vulnerable Individuals, permits the limited reopening of postsecondary institutions and certain business operations, and orders the Executive Director of CDPHE to amend or issue public health orders (PHO) consistent with the directives in this Executive Order. This Order went into effect on April 27, 2020 and remains in effect for 30 days.
