- c) Horticulture and Farmers' Market (Alison & Emily):
 - o Emily had a baby girl named Rhone on January 2. She weighed 7lbs and is 20 in long. Both baby Rhone and Emily are doing well!
 - o Horticulture:
 - See attached 2019 year-end report from the Master Gardener program
 - There are 20 trainees for the 2020 CMG/CGC training that is starting in January. There are two transfers from out-of-state, nine new apprentices, and nine Colorado Gardener Certificate students
 - Alison is scheduled for many public presentations in the coming months, at local and statewide workshops, conferences, and seminars. Topics vary, but there will be an emphasis on newcomer gardening and emerald ash borer.
 - Larimer County Farmers' Market:
 - Rachel Wildman is interning with the Extension Office, focusing on the Larimer County Farmers' Market. Rachel is a senior horticulture student at CSU, has an extensive background in 4-H, and has worked with Pam

Heeney at the Fair in recent years. Rachel will be assisting with all aspects of the market during Emily's maternity leave, and will develop a specific project focusing on the business operations of the market.

 Applications will be available on January 17; musicians and non-profits are currently being scheduled for the 2020 season.

d) Food & Nutrition (Amanda)

Our FCS Agent position community interviews will be on 1/30. Board members are encouraged to attend.

e) Ag & Natural Resources (Karen):

- o January is National Radon Action Month. I will hold six public radon awareness programs around the county in January and February and two private programs for the Larimer County Conservation Corps and the Fort Collins Newcomer's Club. Participants will receive a free short-term radon test kit to test their home.
- 2019 Larimer County Extension Native Plant Master volunteer program impact Volunteers educated 2,829 adults and 850 youth on native plants and noxious weeds. Volunteers also donated 918 hours to the program.

f) Community Development (Sue & Lisa):

- FLTI class of 2020 received 43 applications for a 25-member class. This year will be our first offering in an English-Spanish language justice model.
- Senior Access Points in collaboration with Partnership for Age-Friendly
 Communities has completed a rural Larimer County aging assessment. We
 collected 193 surveys and gathered feedback from 12 community meetings
 along with distributing SAP resources to isolated communities throughout the
 region. We will begin reporting back to rural communities in Feb. and
 connecting rural regions with new aging-related resources.
- While final 2019 numbers are not in yet, between Jan. Nov. 2019, the SAP team distributed 16,054 SAP rack cards and magnets, presented SAP information to 2,935 attendees, and generated 239 new phone calls to the Office on Aging. We have now trained 30 volunteer Ambassadors to deliver SAP outreach to our community.
