The Larimer County Sheriff's Office is releasing the following information pursuant to Colorado Revised Statutes 16-13-901 through 16-13-905, which authorizes law enforcement agencies to notify the public of a sex offender's release when the offender has been determined to be a Sexually Violent Predator and is subject to community notification.

The purpose of this notification is to enhance public safety and protection. Vigilantism or the use of this information to harass, threaten or intimidate the offender, the offender's significant others or the community notification team is criminal behavior and will not be tolerated.
