Introduction

Per the terms of the Memorandum of Understanding (MOU), between Larimer County and Northern Water/ the NISP Enterprise, Northern Water is submitting the Draft Larimer County Intergovernmental Agreement (IGA) Technical Documentation, along with required exhibits and application materials. Summary of Planned IGA

Larimer County and Northern Water continue to work together to draft the terms, conditions, and understandings that will be contained within the planned IGA. The outline and sections for the IGA are as follows.

- 1) Recitals Recitals at the beginning of the IGA include definition and roles for both Larimer County and Northern Water. In addition, the ongoing NEPA Compliance and work with the U.S. Army Corps of Engineers that Northern Water is undergoing is discussed and referenced. Larimer County's regulations and Land Use Code citations are included. The purpose and review extent of the scope of the IGA are encompassed within this section.
- 2) Terms The term of the IGA is defined as the life of the NISP Project.
- 3) Approval The regulatory review and terms of approval are discussed, as well as defining that NISP must proceed in compliance with the terms and conditions of other various state and federal permit requirements.
- 4) Local Measures This section encompasses the bulk of the IGA text and describes the local Larimer County measures and requirements that will be implemented by Northern Water as part of NISP. Some of the items discussed in this section will include compliance with applicable laws, permit requirements, floodplains, fugitive dust, storm water, fire codes, traffic and road impacts, natural resources, etc.

Next Steps

Per the terms of the MOU, Northern Water understands that the next steps for this IGA before going to the Planning Commission and Board of County Commissioners include:
