Welcome to the Public and General Improvement District Program in 2019! Listed below is information related to the program along with some changes to note. **Please share this newsletter with your fellow Board members.**

## PROGRAM INFORMATION

Four new Public Improvement Districts were created during the last election. That brings the total number of active PIDS to 58 in Larimer County, maintaining 123 miles of subdivision roads. Thus, of the approximately 250 miles of public subdivision roads, nearly 50% are maintained with the PID program.

In terms of work completed during 2018, almost \$2.5 million was spent on roadway maintenance and improvements in the PID/GID program.
