





Working Group

- August 01, 2018, BCC's directive to form Working Group
- September through November meetings with Working Group
- November 15, 2018, Community Open House
 - Only original Douglas Road and CR-56 and slight variations were presented by Thornton at their informational booth

Working Group

- Thornton NEVER showed themselves to be open to viable alternatives
- Thornton representatives either refused to answer questions or demonstrated continued evasiveness or incompletely answered questions
- Thornton continually demonstrated that any alternatives to "pipelines" were unacceptable
- Thornton ignored the recommendations and offers of assistance put forth by the Working Group

BCC's Hearings & Criteria for all 1041 Permits

- December 17, 2018, Thornton's 1041 Proposal
- January 28, & February 04, 2019, Public feedback
- Criteria for approval of all 1041 permits:
 - Thornton's use of inductive reasoning
 - Your community's use of clear counter-examples to why Thornton has NOT satisfied ALL criteria, especially as outlined by attorney John Barth
 - Thornton's "Quid Pro Quo" doesn't make the grade

BCC's August 01, 2018 Comments & Directives

- "We are talking about the public process it is important and critical and Thornton has sadly missed the boat on this" - Tom Donnelly
- "I recommend that you sit down with staff and improve the public process, make sure that we include the people on these alternative routes" - Lew Gaiter III
- "We have a duty to the citizens of Larimer County...sometimes we will come up with different opinions on what the best alternatives for our citizens as compared to your citizens" - Steve Johnson

BCC's August 01, 2018 Comments & Directives

- "Even in the presentation tonight one of the things I saw was that once it is permitted (you said) then we will sit down and go through the public process. That's backwards. Go through the public process first and then come back and ask for the permit"
 Lew Gaiter III
- "You said that the quantity of water would be diminished. That's not in my criteria. You said the quality of water would be diminished. That's not in my criteria. You said the cost would be higher. That's not in my criteria." Steve Johnson

BCC's August 01, 2018 Comments & Directives

- "If you live in Larimer I ask you what is the benefit to Larimer County" – Lew Gaiter III
- From the LaPorte Gravel Mine Proposal:
- "I had to ask myself if I would want to live in LaPorte with the mine there" Steve Johnson
- "Commissioner Johnson concluded that not enough evidence had been provided for him to see the project as compatible with the existing community... he voted NO" - North Forty News
