

ELECTION LEGAL NOTICE
November 3, 2020

To the Electors of Larimer County:

Pursuant to Colorado Revised Statutes, Section 1-5-205, notice is hereby given that a General Election will be held on Tuesday, November 3, 2020, between the hours of 7 AM and 7 PM.

The election will be conducted as a mail ballot election. A mail ballot, return envelope, and voting instructions will be mailed during the week of October 12, 2020, to every active voter in Larimer County. Voted ballots may be returned by mail with adequate postage (one first-class stamp) or may be hand delivered to a designated 24-hour ballot drop box, grocery store ballot drop-off location, or Voter Service and Polling Center.

Due to the ongoing COVID-19 public health emergency, in-person voting may be limited or unavailable at certain locations. **THE LARIMER COUNTY CLERK & RECORDER'S OFFICE STRONGLY ENCOURAGES ALL VOTERS TO RETURN THEIR BALLOTS TO A COUNTY-CONTROLLED 24-HOUR DROP BOX OR BY MAIL.** If you *must* vote in-person, please confirm Voter Service and Polling Center availability online at www.votelarimer.org or by phone at 970-498-7820.
