Bison Annual Entrance Permit Application

Thank you for your interest in our Bison Annual Entrance Permit for Larimer County residents. The Bison permit is offered at a discounted cost of \$45 to qualified Larimer County residents who meet certain income guidelines. To qualify, a resident must be 18 years of age, must show a valid photo identification card, show proof of residency in Larimer County, and provide income verification as listed below.

The Bison Annual Entrance Permit is valid for 12 months from the end of the month purchased. The cost of the permit is \$45 and is non-refundable and non-transferable. This permit allows entrance to Larimer County Parks and Open Spaces*. **The permit holder must be present at the time of use for the permit to be valid.**
