- I. Call to Order by Averil Strand at 11:35 AM
- II. Welcome, Introductions and Updates by Agencies
 - Introductions were made between participants.
 - Welcome to Pat Carney, new representative from Foothills Gateway. He replaces Debbie Lapp who has retired.
 - Welcome to Lisa Poppaw, new representative from Crossroads Safehouse, as the domestic violence provider representative. This position has been vacant but is a mandatory partner for our board.
 - Welcome to Mary Ward, Supervisor of the Community and Resource Engagement (CARE) Team at Larimer County Department of Human Services (LCDHS).
 - Retirement announcements: Averil Strand in September, Chris Gastelle in December, and Judy Rodriguez in January.
- III. Review and Approval of Minutes from May 14, 2020
 - A motion for approval was made by Heather Dolan and seconded by Chris Gastelle. Motion approved and passed.
- IV. Community Collaboration Grant Thad Paul, Anthony Silverman, Deb DeLuca-Forzley
 - Thad Paul, Anthony Silverman and Deb DeLuca-Forzley updated us on the federal Community Collaboration Grant: Supported Families, Stronger Community.

- The Larimer County Interagency Oversight Group (LCIOG) is the Advisory Board to the Community Collaboration Grant. The implementation plan for the grant is due at the end of this month and the team has been working to complete the plan. We are set to start programs in October. The Community Collaboration Team (CCT) has and will host world cafes in Fort Collins and Loveland at community locations. The three CCT navigators work with agencies to make connections and direct services to those 2 locations they identify that need services or has gaps. There will be data collection across the two sites.
- V. Review of and Discussion of Placement Data (attached) Sue Statz
 - Sue Statz discussed the tracking and review of children in our system that are in out-of-home care, tracking where they are placed when they are not home. Our goal is to keep children out of congregate care settings and minimize the amount of time spent here and step down to a lower level.
 - In the top two categories there is a significant change in kinship care lines. Referrals and assessments are dropping, and we are removing less children from home due to COVID. Fewer children are coming to our attention with school being out. There will be a potential of higher school referrals when school opens in the Fall depending upon what percentage of children are allowed to attend school. No eyes on students now but if they come back to school LCDHS will see an increase most likely in referrals.
 - Charlie Carter of Thompson School District (TSD) reported changes come
 quickly so the Fall schedule has not been determined yet. TSD is considering
 cohorts for the Fall for children, minimizing the traveling of children between
 areas and groups of children. The staff would go to students instead of
 moving around the building minimizing contact and managing the day so
 both staff and students are having the least amount of contact.
 - Poudre School District was not present so no update on the Fall school schedule.
- VI. Budget Review (attached) Sue Statz
 - Sue Statz reported on the June LCIOG budget. All billings have not been captured yet, but the vast majority have been done. The next two months will be looked at for the LCIOG payback option. It is currently \$241,000 but that will be edited. There is a decrease in services expenditures due to COVID circumstances. There could be additional savings. The final reconciliation should be completed by next month.
- VII. Budget Committee Update and Planning for Next Year (attached) Finance Committee
 - The Budget Committee shared the recommended budget (arrowed column.)
 Created a percentage of each expenditure for new allocated budget amount with everyone getting cut at the same percentage.
 - A motion was made to make a final decision based on the recommended budget by Robert Percifield and seconded by Chris Gastelle. All in favor, motion passed. One member, Averil Strand, abstained from voting as she was not comfortable with cutting direct services.
 - Budget numbers will be updated once we get final numbers for allocation.
 Although the budget proposal was adopted there may be a 2-month lag due to 30 day's notification to providers of cut. (Cuts will go into effect September 1, 2020.) The first two months have been spent already for this fiscal year.
 We recognize that there could be budget overages as we move forward. Staff

position cuts will start September 1, 2020 and fee for service providers due to the notice.

- VIII. Subcommittee to Review Out of Home Placements Update Tegan Camden and Ali Wright
 - Tegan Camden and Ali Wright reported on the Out of Home Placement subcommittee. Respite care continues to be a topic. They also continue to work on ideas for helping us find funding for placement options.
 - Nicole Armstrong of The Matthews House reported on conversations about Detention Alternative Support Homes (DASH). DASH homes provide placement for up to 21 days for children exiting detention before going back home. DASH was successful for this host program to help wrap services around children/youth before going home to keep kids out of child welfare system and helping juvenile justice. Nicole Armstrong will write a grant proposal to fund a new family to family worker that is helping with placements for wrap around services.
 - The Matthews House is applying for grant funding from Larimer County Behavioral Health Services for wrap around services.
 - Is there support from LCIOG to support The Matthews House to go forward with grant application? SummitStone Health Partners is behind this idea. Magistrate Zehe sees good movement on the issue. How do we possibly use this for respite on a short-term basis with the host homes? Host homes could fill the gap and expand for short term respite. A good alternative for temporary care placement besides detention or child welfare placement. Ali Wright reported that Family Assessment Planning Team (FAPT) children could go into this type of temporary placement.
 - A motion was made by the LCIOG Board to support The Matthews House to apply for this grant. The grant application targets a need and fills a gap in the community. The Behavioral Health Grant will be completed by the end of this month by Nicole Armstrong at The Matthews House. Nicole has a budget to share if anyone is interested.
 - Additional work has been done with Tennyson Center for Children for the Rewiring Project. Rewiring is a program Tennyson Center created for an opportunity to serve kids early on with philanthropic funds to help with different funding for services. The concept is to apply for funding to bring a recruiter to the Larimer area. Thad will talk with Tennyson Center for Children and Safe families next week to look for funding to help fund the coordinator.

Definitions for Placement Type

Family Setting:

<u>Trial Home Visit</u>: A child in DHS custody, living away from their parent, is transitioning home. Prior to the trial home visit, criteria and expectations for the visit are defined and submitted to the court.

<u>Kinship Care:</u> A child is **not** in the custody of the Department and is in the care of relatives or friends of the family.

<u>Kinship Foster Care:</u> A child is in DHS custody and is placed with a relative or family member that has been certified, or is in the process of being certified, by the Department.

<u>County Foster Care</u>: The child is in DHS custody and is placed in a Larimer County licensed foster home. The caregivers are not related to the child.

Private Foster Care: The child is placed in a foster home that is licensed by a Child Placement Agency (CPA). That CPA provides oversight and monitoring of the home.

Congregate Care:

<u>Group Home:</u> home-like setting, in which a number of unrelated children live for varying periods of time with a single set of house parents,

<u>Group Center:</u> placement where a number of unrelated children live for varying periods of time with a rotating staff of trained caregivers.

<u>Residential Child Care Facility (RCCF):</u> facility that provides 24-hour care, with rotating staff coverage.

<u>Psychiatric Residential Treatment Facility (PRTF):</u> non-hospital facility offering intensive inpatient services

<u>Psychiatric Hospital:</u> Hospitalization services for youth that are displaying mental health concerns, threatening to self-harm or may pose a risk to the safety of others.

Other:

<u>Independent Living</u>: Adolescent who is in DHS custody and is being assisted to become independent. They may be living in their own apartment or sharing housing with another individual or family.

Run Away: A child or adolescent that is in DHS custody and has left the home of their caregiver, without consent, and their whereabout is unknown.
