A General Election will be held on Tuesday, November 3, 2020, between the hours of 7AM and 7PM.

The election will be conducted as a mail ballot election. Ballot materials will be mailed during <u>the week of</u> October 12, 2020, to every active, registered voter.

Voted ballots may be returned by mail (postage is 55 cents) or hand delivered to a designated ballot drop-off location or a Voter Service and Polling Center.

After October 26, 2020, it is recommended that voters personally deliver their ballot to any of the drop-off locations listed in the following pages of this Notice.

Ballots must be RECEIVED at the Larimer County Elections Office, a designated ballot drop-off location or a Voter Service and Polling Center by 7PM on Election Day, Tuesday, November 3, 2020.

SHALL WELD COUNTY SCHOOL DISTRICT RE-5J TAXES BE INCREASED \$4 MILLION ANNUALLY FOR A LIMITED 10 YEAR PERIOD (BEGINNING IN COLLECTION YEAR 2021). - ATTRACT AND RETAIN QUALITY TEACHERS AND STAFF;

- PROVIDE ADDITIONAL SAFETY, SECURITY, AND MENTAL HEALTH PERSONNEL ACROSS THE DISTRICT; AND

- REPLACE BUSES THAT HAVE REACHED THE END OF THEIR SERVICE LIFE AND MAINTAIN TRANSPORTATION SAFETY.

#### Summaries of written comments filed with the election officer:

#### The following summaries were prepared from comments filed by persons FOR Ballot Issue 5A:

The State of Colorado has withheld more than \$31 million from Weld RE-5J over the past 10 years due to the budget stabilization factor. These funding cuts, coupled with one of the lowest tax rates compared to other school districts in the area, are precisely why the District has been unable to use existing revenues to address its highest priority operating needs.

Voter approval of Issue 5A will address many critical needs, including:

- · Attracting and retaining quality teachers and staff
- Expanding Career and Technical Education (CTE) programs at the middle school and high school
- Providing additional safety, security and mental health personnel across the District
- Replacing buses that have reached the end of their service life and maintaining transportation safety

Neighboring school districts continue to aggressively recruit some of our most experienced, highperforming teachers and staff. This includes hard-to-replace math, science, special education and ESL teachers. Reducing employee turnover will positively impact the quality of our schools, improve student performance and save taxpayer dollars.

It's expensive to recruit and train teachers, and then see them leave for better pay in neighboring districts. Your YES vote on 5A helps put an end to this revolving door.

Passage of 5A will also better prepare students for future careers by expanding CTE programming. Providing students the opportunity to explore careers and to gain marketable skills while still in middle and high school is important. These programs also keep students engaged in school.

Giving students the support they need, and keeping them safe while at school, has never been more important than it is today. Issue 5A ensures that each Weld RE-5J school—and not just some—have the necessary safety, security and mental health professionals in place.

Lastly, getting students to and from school safely requires replacing outdated buses that have reached the end of their service life, which Issue 5A addresses.

5A is an investment of \$3.73 per month per \$100,000 of a home's actual value. For seniors and disabled veterans who qualify for the Colorado Senior Property Tax exemption, the tax impact is even lower.

The mill levy override will also have a 10-year sunset, as strongly requested by district taxpayers.

All funds from the MLO will stay local and be publicly disclosed on the District's website. Furthermore, the tax will not go into effect until 2021.

Issue 5A is a no-frills proposal that deserves our support. Your YES vote will allow Weld RE-5J to attract and retain quality teachers and staff, expand and improve career-focused programming, and enhance the safety, security and well-being of our students. It's a fair and reasonable proposal that deserves our support.

Issues 5A and 5B work hand in hand to strengthen Weld RE-5J's schools, protect property values and position our communities for a very strong future. These two ballot measures will positively impact the lives of thousands of students for a lifetime.

## The following summaries were prepared from comments filed by persons AGAINST Ballot Issue 5A:

We should vote NO on the MLO issue for the following reasons. Now is not the time to add additional tax burdens on the community. Families' lives have been upended in the past several months due to the significant effects of the Covid epidemic. Many are struggling financially due to layoffs and the devastating impact on our region's economy as a result of the shutdown. The changing financial landscape also has families worried about their economic future. They do not need the weight of an additional and unexpected expense.

We also have Seniors and retirees who live on a fixed income and are unable to afford the proposed increase in property taxes. No inventive way to create an approach to spread out or reduce the tax burden or exempt them entirely was offered. They have family who attend the schools and are concerned about the state of the facilities and security of the children. Many simply cannot afford it as proposed.

27.5% or \$1,100,000 is the largest part of the \$4,000,000 annual amount of the MLO. It is slated to be used to attract and retain Teachers/Staff/Aides. Per the Colorado Department of Education data, the Districts overall proficiency rate for ELA and Mathematics is in the low 30 percentile and mid 20 percentile, respectively. We keep throwing money at this problem with no drastic improvement in proficiency rates. It can be better utilized elsewhere to improve the districts performance results.

The roughly \$160 annual tax increase (for a \$350,000 assessed valuation of a home) as proposed in the MLO has a qualifier. Per the district, "If oil and gas valuation is reduced, the estimated tax impact would increase." Our oil and gas industry has been decimated by the lockdown, market forces and the actions taken by our governor and legislature. The likely result is a reduction of the assessed value of the industry, which if deemed so by the assessor's office, will transfer more of the tax burden to homeowners. Basically, this requires all of us to pick up the slack as oil and gas tax revenues plummet. This is an open-ended bottomless pit. Essentially if these revenues drop further due to things beyond our control (national and international economic and political events) you are required to make up the difference above and beyond the tax liability stated in this measure. Wouldn't it be better to revisit this loss of revenue in the future when we can evaluate how the stewards of our hard-earned tax dollars have done to that date?

Remember, if we commit to this measure there is no undoing it for a 10-year period. Higher tax bills and future uncertain liabilities will cause economic hardships on families and hang like a shroud over the value of our homes. This tax increase will be in addition to any other measure on the ballot containing a tax increase. Vote no.

#### Summaries of written comments filed with the election officer:

#### The following summaries were prepared from comments filed by persons FOR Ballot Issue 5B:

It has been 17 years since voters in Weld County RE-5J School District approved funding to address school building improvements. With many of the District's schools more than 50 years old, building upgrades are long overdue.

This is our best chance to address much-needed school facility improvements at the lowest possible cost. Why? Because the State of Colorado is providing a major grant that does not need to be repaid and land is being donated. Borrowing costs also remain near historic lows. We're not going to have an opportunity like this again.

Voter approval of Issue 5B will address Weld RE-5J's highest priority school building needs, including:

- Replacing Letford Elementary School on land donated by the Town of Johnstown by providing matching money required to receive an awarded \$9.5 million State BEST grant
- Constructing a new Roosevelt High School at a new location
- Converting the existing high school into a middle school
- Making improvements to Milliken Elementary School and Pioneer Ridge Elementary School to address safety and security needs, extend their useful life and reduce costly emergency repairs
- Addressing repairs and improvements to the Early Learning Center and Knowledge Quest
  Academy facility

The improvements to Weld RE-5J's schools will provide many benefits to our students and community, including:

- Making schools healthier, safer and more secure
- Reducing costly emergency repairs
- Extending the useful life of existing facilities
- Enhancing energy efficiency, saving taxpayer dollars
- Improving Americans with Disabilities (ADA) accessibility
- Addressing overcrowding
- Creating flexible learning spaces that can quickly adapt to current and future teaching methods and new programs
- Better preparing students for college and the workforce by providing more space for CTE and STEM programming
- Protecting local property values

Issue 5B is an investment of \$7.89 per month per \$100,000 of a home's actual value that will provide \$159 million in funding. For seniors and disabled veterans who qualify for the Colorado Senior Property Tax exemption, the tax impact is even lower.

All revenues and spending associated with Issue 5B will be disclosed on the Weld RE-5J website. The District will also host project updates. We've kicked this can down the road long enough. The longer we wait, the more it's going to cost. It's time.

We are a tight-knit community that has always stood up for our students and schools, and we take pride in supporting the Rough Rider tradition of rising to the challenge. The challenge facing the Rough Rider community today is the need to repair or replace aging school buildings at the lowest possible cost, which can be accomplished with the passage of Issue 5B.

Issue 5B is a community-driven, fiscally prudent proposal that addresses the needs of our students and our taxpayers. Issue 5B deserves our support.

## The following summaries were prepared from comments filed by persons AGAINST Ballot Issue 5B:

We should vote NO on this Bond Issue for the following reasons. Now is not the time to add additional tax burdens on the community. Families' lives have been upended over the past several months due to the significant effects of the Covid epidemic. Many are struggling financially due to layoffs and the devastating impact on our region's economy as a result of the shutdown. The changing financial landscape also has families worried about their economic future. They do not need the weight of an additional and unexpected expense.

We also have Seniors and retirees who live on a fixed income and are unable to afford the proposed increase in taxes. No inventive way to create an approach to spread out or reduce the tax burden or exempt them entirely was offered. They have family who attend the schools and are concerned about the state of the facilities and security of the children. Many simply cannot afford it as proposed.

The Bond proposal has a repayment over its term of up to \$276,000,000. This is in addition to the \$50,000,000 liability for the district's costly pension benefits. Instead of proposing a more digestible bond measure only replace Letford Elementary, which is the most critical need the district faces, we are being saddled with the sudden tax burden of a 16+ year period of lack of care and neglect to

facilities. The time to play catch-up for previously ignored facility issues is when the economy is again strong. With our current teaching model, many of the facilities requiring maintenance are and will continue to be underutilized.

The auditors project the student growth rate to be 1% annually for the next couple of years, less than 40 students per year. For example, modular units can be shuffled around to meet demand: building or repairing more permanent facilities reduces flexibility - you can't move the classroom to another school where it is needed.

The roughly \$330 annual tax increase (for a \$350,000 assessed valuation of a home) as proposed in the Bond measure has a qualifier. Per the district, "If oil and gas valuation is reduced, the estimated tax impact would increase." Our oil and gas industry has been decimated by the lockdown, market forces and the actions taken by our governor and legislature. The result is a reduction to the assessed valuation of the industry, which will transfer more of the tax burden to homeowners. Basically, this requires all of us to pick up the slack as oil and gas tax revenues plummet. This is an open-ended bottomless pit.

Remember, if we commit to this measure there is no undoing it. Higher tax bills and future uncertain liabilities will cause economic hardships on families and hang like a shroud over the value of our homes. This proposed tax increase will be in addition to any other measure on the ballot containing a tax increase. Vote no.
