

ELECTION LEGAL NOTICE
November 2, 2021

To the Electors of Larimer County:

Pursuant to Colorado Revised Statutes, Section 1-5-205, notice is hereby given that a Coordinated Election will be held on Tuesday, November 2, 2021, between the hours of 7 AM and 7 PM.

The election will be conducted as a mail ballot election. A mail ballot, return envelope, and voting instructions will be mailed during the week of October 11, 2021, to every active voter in Larimer County. Voted ballots may be returned by mail with adequate postage (one first-class stamp) or may be hand delivered to a designated 24-hour ballot drop box or a Voter Service and Polling Center.
